

## 2016 Mortgage Interest – Form 1098 Complete Redesign!

Five new boxes, which have been highlighted in yellow, were added to Form 1098 for tax year 2016, in addition other boxes have been renumbered as shown below. MIP (Mortgage Insurance Premiums) is now Box 5. Also note that the penalty for not mailing and filing can be \$520 per form!

We STRONGLY recommend that you test importing your data in NOVEMBER to avoid IRS Penalties for late mailing and late filing. Attached is an excel file with the new headings for the 2016 Form 1098 as a guide for your imports, or you can find this file in your import folder. (Default location: C:\1099 Pro\Pro99T16\Import)
