## **TRAINING & SETUP**

Live one-on-one training using screen sharing software is free with the Corporate Suite software. A designated Account Manager oversees the implementation, conversion, and training process and provides demonstrations for users. Basic tutorials for new users are available on our website, and custom tutorials can be created, based on specific client needs. Onsite technical training is also available.

## **IMPORTING**

Corporate Suite provides customizable import maps and supports delimited, Excel, and fixed-length imports. Multifiler and transactional imports are included, as well as automatic imports via scheduler. Extensive business rules based on IRS regulations are built-in to the software to validate recipient data upon import. Error or warning messages are triggered based on the severity of the IRS rule/regulation, to ensure accurate reporting. Corrections and reprints may also be imported.

## **PRINTING & MAILING**

Import or key-in paper IRS CP2100, 972CG Notices, and bulk TIN responses into the Corporate Suite software. Manually or automatically attach returned W-9s via barcode. The 1099Pro.NET web module enables users to instantly check TIN and Name combinations in real time.

#### **FILING**

Electronically file IRS/SSA originals, corrections, replacements, tests, and state files. Corporate Suite also includes W-2 SUTA files, Puerto Rico, quarterly files, and Massachusetts 1099-HC XML files. Our Service Bureau can also file with the IRS or SSA on your behalf.
